

# **Guild Senior Leaders**

## Amy C. Sousa, PhD, Chief Executive Officer

Amy, who has committed her career to the health and safety of families, came to The Guild for Human Services after five years as executive director of Wediko Children's Services, a nonprofit organization headquartered in Boston.

Prior to joining Wediko, she served as executive director of the National Organization for Victim Assistance, interim executive director of the New Hampshire Coalition Against Domestic and Sexual Violence, and public policy manager for the Pennsylvania Coalition Against Domestic Violence. Additionally, Amy has been a technical assistance provider for the U.S. Department of Justice's Office on Violence Against Women, consultant to the Environmental Protection Agency and graduate fellow in the Office of U.S. Sen. Edward M. Kennedy.

Amy's research has been published in the professional journals Symbolic Interaction and Disabilities Studies Quarterly. She has been on the faculty of Boston College and the University of Massachusetts Lowell. Her advocacy has taken her throughout the United States and to destinations around the world, including Ghana, Togo, Benin and Morocco.

A native of New Hampshire, she received a BA and PhD from Boston College and an MSc from the London School of Economics and Political Science.

As chief program officer, Maureen oversees the school and adult residential programs with a focus on ensuring The Guild provides safe, therapeutic homes for all students and adult residents. She brings to the Guild more than 25 years of experience as both a manager and consultant for organizations supporting children and adults with disabilities, and a lifelong commitment to improving the quality of life for individuals with disabilities.

Prior to joining The Guild, Maureen served as vice president of a public sector management consulting firm that worked with school systems across the country. She also worked in a variety of capacities for the state Department of Developmental Services, managing both facility- and community-based residential services.

She received her MEd in intensive special education from the University of Vermont's Center for Developmental Disabilities and a BA in special education from Simmons College.

Maureen is treasurer of the board of L'Arche Irenicon, a residential community that supports adults with developmental disabilities, and serves on the Human Rights Committee at American Training.

#### Jennifer Magnuson, MA, BCBA, Chief Clinical Officer

Jennifer oversees a team of 20 direct-care providers and is responsible for the creation, implementation, evaluation and integration of clinical supports and techniques for students and adults with developmental and intellectual disabilities, mental health disorders, and autism.

Beginning in 2014, she served as a behavioral consultant at the Eastern Massachusetts consultation division of the May Institute in Randolph, where she worked with parents, teachers and other support specialists to design and implement behavior plans for students with a wide variety of backgrounds. She earlier worked as a clinical services coordinator in behavioral psychology at the Kennedy Krieger Institute in Baltimore, and was a teacher and educational case manager at the May Institute's Center for Child Development.

Jennifer has completed coursework toward a PhD in psychology from Syracuse University, earned her master's degree in applied behavior analysis from Northeastern University and received her bachelor's in psychology from Eastern Nazarene College.
